### **DECLARATION OF FAILURE OF BIDDING**

**WHEREAS**, MKWD under LWUA-ADB funded projects posted an invitation for Package 5 Lot B Procurement of Supply and Installation of Data Loggers, CCTV System and Other Equipment (Re-Bidding);

**WHEREAS**, Approved Budget of Contract (ABC) for Package 5 Lot B is PhP **50,140,000.00** (Set 1- PhP 24,350,000.00, Set 2- PhP 20,600,000.00 and Set 3- PhP 5,190,000.00);

**WHEREAS**, no bidders purchased the bidding documents and participated on the scheduled Opening of Bids last January 08, 2021 for Package 5 Lot B- **Set 2-** Data Loggers and Other Equipment;

**WHEREAS**, Section 35.1 (a) of the Revised IRR of R.A. 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

**WHEREAS**, Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

**WHEREAS**, Section 35.3 of the same Act provides that the BAC shall conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the IRR;

**NOW, THEREFORE**, the BAC hereby resolves, as it is hereby resolved, to recommend to the Hope of the Procuring Entity the declaration of failure of bidding for the procurement of the activity above and the conduct of a re-bidding;
