JOB ORDER CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

METRO KIDAPAWAN WATER DISTRICT a Government-Owned and Control Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198 as amended, with office address at Lanao, Kidapawan City represented by its General Manager, **STELLA M. GONZALES, MPS**, duly authorized for this purpose, herein called the WATER DISTRICT.

And

JOEL V. MANDALUNES, Filipino and a resident of Purok 4A Manongol, Kidapawan City herein after called the **AWARDEE**.

WITNESSETH:

WHEREAS, in response to the WATER DISTRICT's invitation to supplier, the AWARDEE submitted proof of its bid to WATER DISTRICT to perform the work as stipulated in the **Job Order No. 1220-0026**.

WHEREAS, the bid of the AWARDEE is the Lowest Calculated and Responsive Bid received;

WHEREAS, the WATER DISTRICT awarded the Contract to the AWARDEE at the price stipulated in its winning bid;

NOW THEREFORE, for and in consideration of the foregoing premises, both parties hereto agree as follows:

The **AWARDEE** agrees and binds itself to fully and faithfully provide for **1 LOT HIRING OF LABOR-ONLY CONTRACTOR FOR THE INSTALLATION OF SITIO ORO VERDE PARALLEL LINE DL, SIKITAN, K.C.** as stipulated in Notice of Award as per approved **Job Order No. 1220-0026** within **Twenty Seven (27) days** upon receipt of the Notice to Proceed with the following terms and conditions:

SPECIFICATIONS:

1. Mobilization and Hauling of Materials on site from Manongol Reservoir to Sitio Oro Verde, Brgy. Sikitan Kidapawan City
2. Manual Earth Works-260 meters excavation and Backfilling (0.60m depthx0.4m wide) including boulders removal
3. Pipes and Fittings Installation 48 units
4. Pressure Leak Test and Disinfection 1 section
5. Air Release Valve Installation/Construction of Concrete Box 1 unit

6. Interconnection/End Point Flushing 2 sets
7. Pipe Culvert Crossing Installation
8. Vertical outlet installation 3 units
9. Safety Provision and Tarpaulin
10. Thrust Block Concrete Pad and Painting Works
11. Surface Restoration
12. Contractor Service
13. Wear PPE and Proper dress code must be observed
14. Tools will be provided by the contractor
15. On-site works as per instruction of Project Facilitator
16. Individual covered of personnel insurance

Payment Term: EVERY 15TH & 30TH PER ACCOMPLISHMENT

1. The AWARDEE shall assure that works required and to be performed shall be in accordance with the specifications and descriptions provided for fixed time after delivery, a warranty (3 MONTHS) shall require wherein obligations for which shall be covered by either retention monies in the amount equal to ten (10) percent of the total contract price. Such amount shall be released after the warranty period.
2. *In the event that the AWARDEE refuses or fails to meet the specified work description shall pay the WATER DISTRICT for liquidated damages equivalent to at least one-tenth of the 1% (.001) of the cost of unperformed and services for every day of delay. Once the cumulative amount of liquidated damages reaches ten (10) percent of the contract, WATER DISTRICT may rescind or terminate the contract without prejudice to other courses of action and remedies available under the circumstances.*
3. The contract shall become effective and binding on the date that the AWARDEE conformed and signed in the Notice of Award and Notice to Proceed. Any modification of the contract shall only be allowed upon written approval by the WATER DISTRICT.
