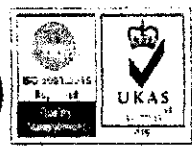

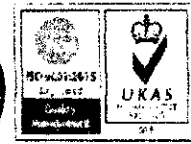

JOB ORDER CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

GONZALES, MPS**, duly authorized for this purpose, herein called the **WATER DISTRICT**.

And
