GONZALES, MPS, duly authorized for this purpose, herein called the WATER DISTRICT.

JVIM Enterprises, a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines with office address at Davao City represented by its Proprietor, herein after called the AWARDEE

### WITNESSETH:

 In the event that the AWARDEE.

2. In the event that the AWARDEE refuses or fails to meet the specified work description shall pay the WATER DISTRICT for liquidated damages equivalent to at least one-tenth of the 1% (.001) of the cost of unperformed and services for every day of delay. Once the cumulative amount of liquidated damages reaches ten (10) percent of the contract, WATER DISTRICT may rescind or terminate the contract without prejudice to other courses of action and the contract shall the contracts.

3. The contract shall become effective and binding on the date that the AWARDEE conformed and signed in the Notice of Award and Notice to Proceed. Any modification of the contract shall only be allowed upon written approval by the WATER DISTRICT.
